# **DIRECTIONS:**

# From I-30 in Greenville, TX to Wolfe City

Exit Hwy 34 North (Exit #93). Follow Hwy 34 (aka Wesley St.) thru Greenville (4 miles) Continue to follow the signs through town. Hwy 34 makes a right turn (aka O'Neal St.) near AutoZone & Dollar General. Go 2 blocks and turn left (aka Johnson St.). Cross bridge and continue on Hwy 34 past downtown. At fork in road, veer right for Hwy 34 (Wolfe City/Commerce). After fork, take a left at Phillips 66 (still Hwy 34). Continue north on Hwy 34 for approx 14.6 miles to Wolfe City. In Wolfe City, Hwy 34 turns left (aka Santa Fe St.). Continue with the directions From Wolfe City.

# From Commerce, TX to Wolfe City

From the University Inn, turn right out of the parking lot onto Hwy 50 heading into Commerce. Take the exit ramp for Hwy 11 headed Northwest (turn left). Follow highway 11 to Wolfe City. Turn right on Hwy 34 and continue with the directions From Wolfe City.

## From Wolfe City to LSDC

After leaving Wolfe City, continue on Hwy 34 for approximately 4-5miles Turn left on CR 3355 (white gravel road).

**ENTRY FEE: \$30.00** per entry for all stakes each day. No charge for Best of Open, Best of FC or Absolute Run. **Make checks payable to Dallas-Fort Worth Dachshund Club**. Be sure to bring your dogs' entry information with you. Dogs must be present on the grounds at the time entries close to be officially entered. Owner is responsible for correct information on the entry forms. You may copy the enclosed form if you need more forms.

**RUNNING ORDER:** Classes will run consecutively. Running order on Saturday will be OD, FCD, OB, FCB, on Sunday OD, FCD, OB, FCB as the field becomes available Best Open, Best Field Champion, and Absolute. Be prepared for this running order. Judges will not wait for dogs except as provided for in the AKC rule book. The committee reserves the right to make changes to the running order to expedite the event.

**GROUNDS:** The grounds will be available Thursday, December 7th after 12:00 noon for set-up or unless prior arrangements have been made with LSDC. All setups must be removed 2 hours after the completion of the event on Sunday, December 9th.

**PARKING:** Day parking will be in the upper lot near the pavilion. Please be respectful of others by limiting the amount of space you use. The Field Trial Committee reserves the right to limit the amount of space used by individuals. DFWDC and LSDC reserve the right to direct vehicle parking. Crating and EZ Ups are not allowed on the parking surface unless at the direction of LSDC Members.

Please clean up after you dogs and do not leave filled baggies on the grounds. The event committee and landowners ask that exhibitors remove their trash from the grounds each night.

The use of tracking collars will not be allowed during these trials.

All dogs must be on lead or in <u>secure</u> ex-pens/crates at all times except when under instruction of the judges during the running of the stakes. It is strongly suggested that NO DOGS BE LEFT UNATTENDED IN EXPENS.

**DRESS:** It is recommended that sturdy shoes or boots and durable clothing be worn. Bring appropriate gear as the trial will be run rain or shine.
